Each apartment is fully carpeted and comes equipped with blinds, a stove and refrigerator. Laundry facilities are located on both the first and second floors. There is ample off-street parking and mail delivery is provided.

Each apartment is individually heated with an efficient gas forced air system and has its own gas fired hot water tank. Units are prewired for phone and cable TV. **ALL UTILITIES** are the responsibility of the tenant *except for* sewer, water and garbage pick-up.
